Who can get help at FJCSC?

**Victims and survivors of domestic violence,
dating violence, elder abuse, child abuse
and sexual assault.**

The signs of abuse:

- Physical harm
- Threats of physical harm
- Intimidation
- Depriving of food, sleep,
and/or money
- Forced sexual contact
- Restraining someone from leaving
- Emotional abuse

**We are a SAFE zone. Services are available in
multiple languages, including Spanish.**

On Site Services:

YWCA Sonoma County

The Domestic Violence Advocates provide assistance and resource information, as well as English and Spanish support groups, to victims of domestic violence.

Verity

The Sexual Assault Advocate provides crisis intervention and case management for survivors of sexual assault.

Council on Aging

The Elder Abuse Advocate provides support and resources to victims of abuse, age 60 and over, including elderly victims of financial abuse.

Counseling Services

An onsite licensed therapist provides 12-week therapy sessions to FJC clients.

Legal Aid of Sonoma County

An attorney and bi-lingual legal assistant provide assistance with domestic violence, elder abuse and civil harassment restraining orders, including in-court representation in some cases.

Catholic Charities

The Board of Immigration Appeals (BIA) Accredited Representative provides information and assistance to apply for temporary legal status for undocumented victims of crime; which may lead to a pathway for permanent residency.

Victim Services

A division of the District Attorney's Office that offers crime victims advocacy throughout the criminal justice process and assistance with victim compensation and restitution for losses related to the crime.

Deaf and Hard of Hearing Services

Deaf advocates, interpreting services, and various technologies are available to assist clients.

Department of Health Services

The Behavioral Health Division's licensed clinical staff member provides mental health assessments, crisis services, and referrals.

Human Services Department

Redwood Children's Center (RCC) is an accredited child advocacy center providing forensic interviews, medical exams, and advocacy services to children and families involved in criminal and/or child welfare investigations.

District Attorney's Office

Specially trained prosecutors and investigators in the Domestic Violence/ Sexual Assault and Elder Protection Units handle sex crimes, child abuse, intimate partner violence, and crimes against elders. They work to hold offenders accountable and assist victims through the criminal justice process.

Law Enforcement

The FJCSC houses detectives from the Sonoma County Sheriff's Office and the Santa Rosa Police Department who focus their efforts on crimes of violence including sexual assault, child molestation, child abuse and neglect, and domestic violence.

Camp HOPE

Camp HOPE is a week-long camp for children exposed to family violence.
